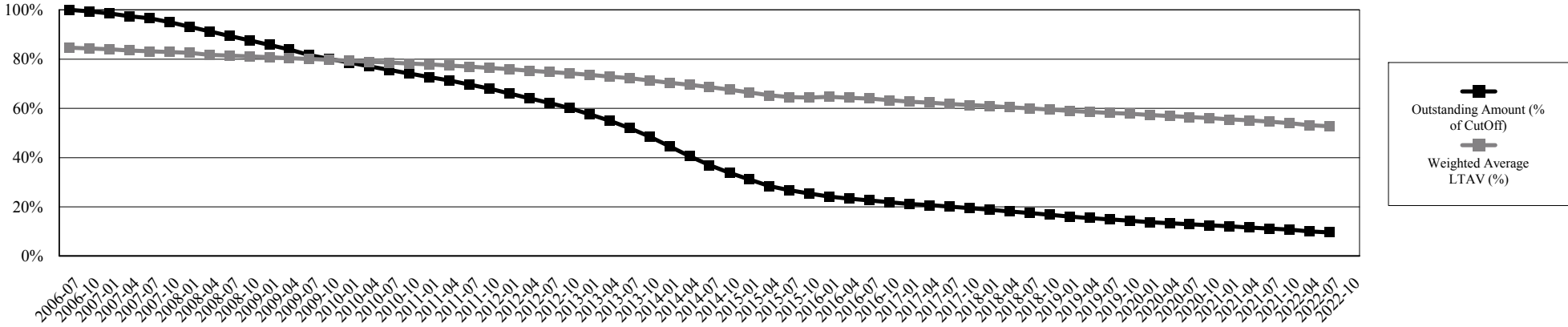

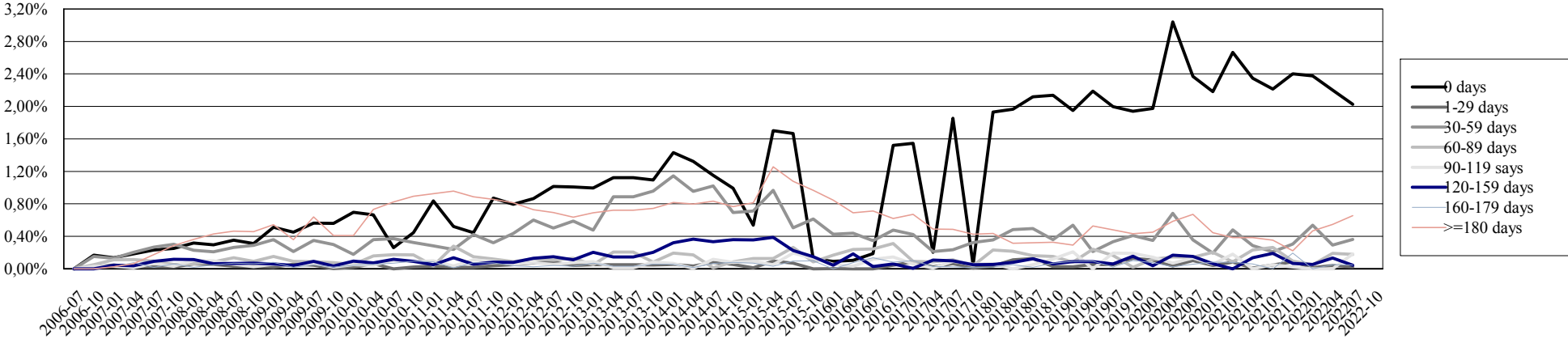

(Principal Outstanding of Delinquent Reference Claims in % of Current Principal Balance)



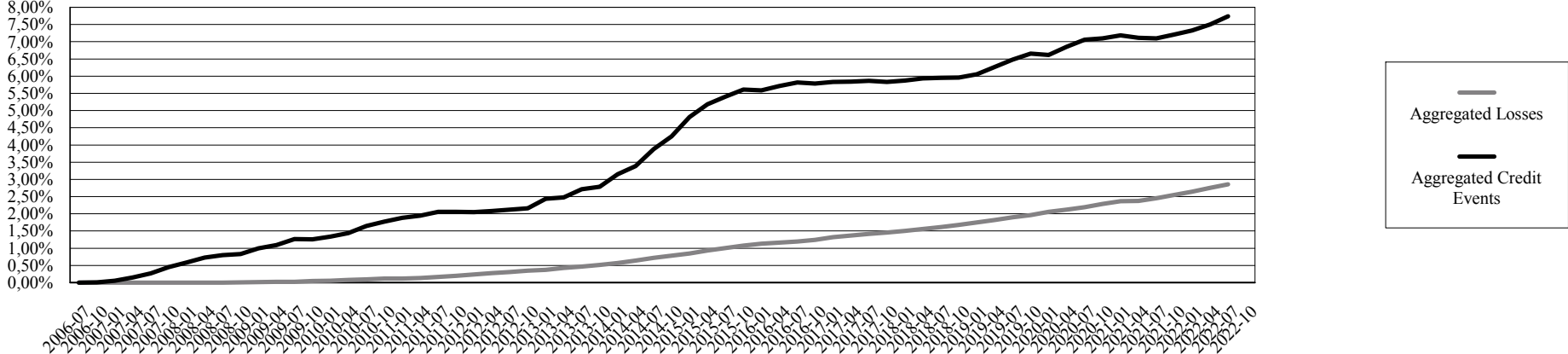
